You are cordially invited to attend the 2015 Mid Council Financial Network Meeting, which will be held in San Antonio, Texas, at the Holiday Inn Riverwalk Hotel.

The meeting will begin Wednesday, November 18 with breakfast, and conclude on Friday, November 20, adjourning around noon.

This is a continuing education and training opportunity for church financial persons and staff or volunteers working with the finances in the presbyteries and synods. Representatives from Office of the General Assembly, Presbyterian Mission Agency, Board of Pensions, Presbyterian Foundation, Presbyterian Investment and Loan Program, Presbyterian Publishing Corporation, denominationally endorsed insurance programs, and other key vendors will be on hand. Keynote speaker will be Dr. Heath Rada, Moderator of the 221st General Assembly. Plenary Speakers, back by popular demand, will be Frank and Elaine Sommerville, authorities on church law and tax.

The Special Dinner Event will be held Thursday night at the Rio Plaza, with entertainment provided by Mariachi Sol de San Antonio Band.
